IFTA, Inc. and Associated Jurisdictions:

Please be advised that Washington State is amending its previous notice requesting non-enforcement of Washington IFTA carriers. The amended notice (attached) extends the requested non-enforcement date to June 30, 2020.

Additionally, all Washington Department of Licensing public offices are currently closed to the public until further notice. For registrants needing information, staff are available via email ([MotorCarrierServices@dol.wa.gov](mailto:MotorCarrierServices@dol.wa.gov)) as well as by phone (360-664-1858) from 8:00am through 4:30pm PST. All services are available online and by email/phone. New IFTA decals and licenses are being processed, but with some delay at this time.

Furthermore, under the authority of the state of emergency declaration in Washington State and [RCW 82.38.150\(6\)](#), the 1<sup>st</sup> quarter IFTA return due date is hereby extended to June 30, 2020, and continues to include all travel and use of fuel between January 1 and March 30. All other return due dates remain unchanged, and all other requirements for the content of quarterly returns remain in place.

Kindly include the updates listed above on the IFTA, Inc. site and associated operational status documents for carriers and other jurisdictions.

To whom it may concern:

The Governor of the State of Washington has issued Proclamation 20-05 through 20-49 proclaiming a State of Emergency for all counties throughout the state of Washington as a result of the coronavirus disease 2019 (COVID-19). Under the authority of these proclamations, the Governor has directed state agencies and departments to do everything reasonably possible to support the implementation of the *Washington State Comprehensive Emergency Management Plan*.

Under this authority, the State of Washington rescinds its previous notice dated March 20, 2020, and requests the following support from participating jurisdictions and law enforcement communities in its place:

- The expiration of an apportioned registration under the International Registration Plan, with expiration dates of March 31, 2020, April 30, 2020, and May 31, 2020 are hereby suspended and the expiration date is extended to June 30, 2020;
- All Temporary Evidence of Apportioned Registration (TEAR) documents issued after March 1, 2020, regardless of expiration date, are hereby extended and expire June 30, 2020;
- Additionally, we ask that all IFTA jurisdictions waive and delay enforcement action on Washington based vehicles operating in your jurisdiction without IFTA decals and licenses until June 30, 2020.

**Carriers operating under these extensions and/or exemptions shall carry a copy of this notice in their vehicle while operating. This exemption is valid until June 30, 2020, or upon further notice of the Department, whichever occurs first.**
