#### ID: \*\* FUEL PURCHASED ON IDAHO INDIAN RESERVATIONS - As

of November 1, 2007, diesel purchased from retail outlets on the Shoshone-Bannock Indian Reservation is Idaho tax-paid diesel for IFTA reporting and Idaho fuels tax refund purposes. However, diesel purchased from tribal-owned retail outlets on the Coeur d'Alene and Nez Perce Indian Reservations is not Idaho tax-paid diesel for IFTA reporting and refund purposes. Also, as of March 1, 2005 all gasoline purchased from tribal-owned retail outlets on all Idaho Indian reservations is not Idaho tax paid gasoline and is not eligible for fuels tax refunds. #### PCRC Survey

The system will email one copy to you as the sender. Each recipient will receive the email showing you as the sender as well. In the past, it appeared that I had sent the email. Additional coding will be added next month for more enhancements.

# Clearinghouse Update

#### Derived by IFTA, Inc.?

If you have spent any amount of time on the transmittal pages you would have noticed 'Derived by IFTA, Inc.' littered across the web pages. So let's explain what this really means.

When your jurisdiction or your vendor send in transmittal data IFTA, Inc. receives two files. One file that shows all the transmittal detail and a summary file. The summary file is the monetary and distance totals for your jurisdiction to every other jurisdiction.


Over time there have been requests to break down the data by filing version (see the top section of any transmittal page) or by fuel types and return periods (see the Fuel and Distance report). In order to break this data down IFTA, Inc. has to take your data and do some calculations with it. Therefore, anywhere you see 'Derived by IFTA, Inc.' that means we are coming up with the totals or breakdowns.

'Derived by IFTA, Inc.' totals are a way for your jurisdiction to quickly spot check any inconsistencies that may have been sent in the summary file. The use of the 3rd search engine on the transmittal homepage will give you a quick glimpse of the summary totals sent in and the totals as calculated from the transmittal detail file. As you know by now these totals are 'Derived by IFTA, Inc.'.

With this method we have seen some examples where the Total Due as sent in the summary file doesn't match the total due as found in the details files. So when totals don't match what should you do?

You should call the base jurisdiction that posted the transmittal. That should be your first move. From there a call to IFTA, Inc. can also verify that what IFTA, Inc. totaled is indeed correct. We can run further tests on this end for verification if there is any question that our totals may not be correct.

Take advantage of this spot checking. It's there as a helpful tool to help you get more done in less time.


