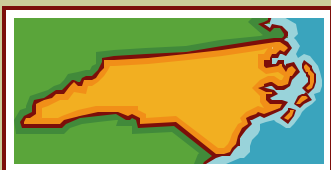

This area is utilized for not only Clearinghouse Transmittal Notifications but also for core functions such as the Interjurisdictional E-Mail Exchange.

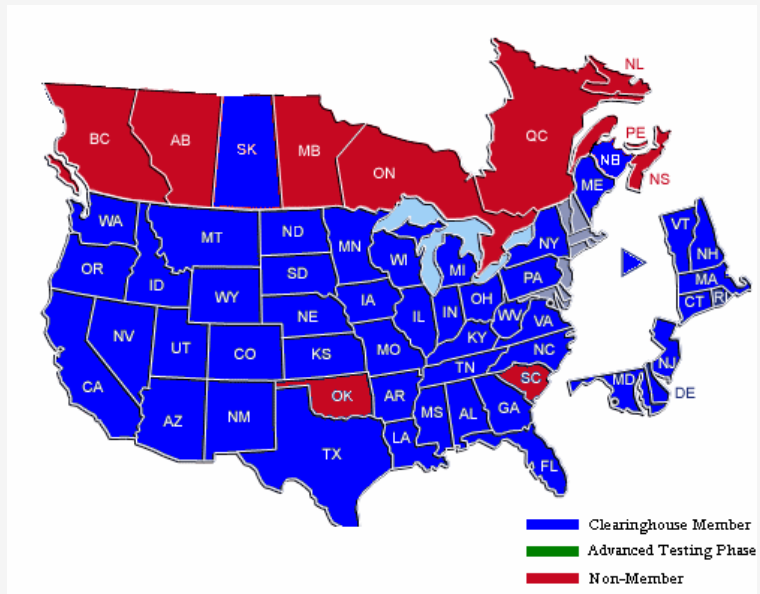

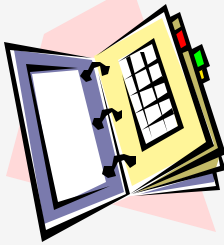
Funds Netting

Behind the scenes here, and until the Annual Business Meeting in July, we will be running funds netting on a monthly basis. Testing for us will be Maine, Saskatchewan, Kansas, and Mississippi. We are verifying uploads based on a strict calendar and obtaining total due amounts between each test jurisdiction. In July we will give the results of this test, remedy any issues that arise, and hopefully give you a complete working model of the whole funds netting process.

Revoked Enforcement Database

We have tried to make it as easy as possible to allow your local jurisdiction enforcement to start obtaining Revoked carrier information. The Revoked Only database is now fully available to allow for revoked carrier lookups. User registration now contains a user option for Enforcement. Please take advantage of this additional feature to better monitor the IFTA Carriers at the roadside level.
