Demographics Update

The link at the top of the Demographics page called 'Carriers in Multiple Jurisdictions' is a new page for you to use. What this page does is it allows you to choose a jurisdiction, then you choose a status type. It will look for any carrier in your jurisdiction that is also operating in another jurisdiction based on the status type you chose.

So, if you would like to find any carrier in your jurisdiction that is revoked in any other jurisdiction, participating members only, then this is the page to use.

Funds Netting Quick FAQ

You have between January 1, 2010 and January 26, 2010 at 10:00 p.m. Eastern to upload your Transmittal Data for the first ever Funds Netting run.

Transmittal data WILL NOT BE CONSIDERED FINAL until January 26, 2010 at 10:00 p.m. Eastern.

This means any and all data could be replaced until the last upload date of January 26th, 2010 at 10:00 p.m. Eastern.

As a user you should keep this in mind and not assume that a Transmittal that is posted is final. Please wait until January 27th, 2010 for any and all transmittals to be final.

Jurisdictions during this time period should make it a habit to review their data as it's posted by jurisdiction or your vendor. When the Transmittal data is considered final, on January 27, 2010, the data will not be removed, replaced, or deleted at any time after that date. Corrections to past data may only be done in future transmittals.
