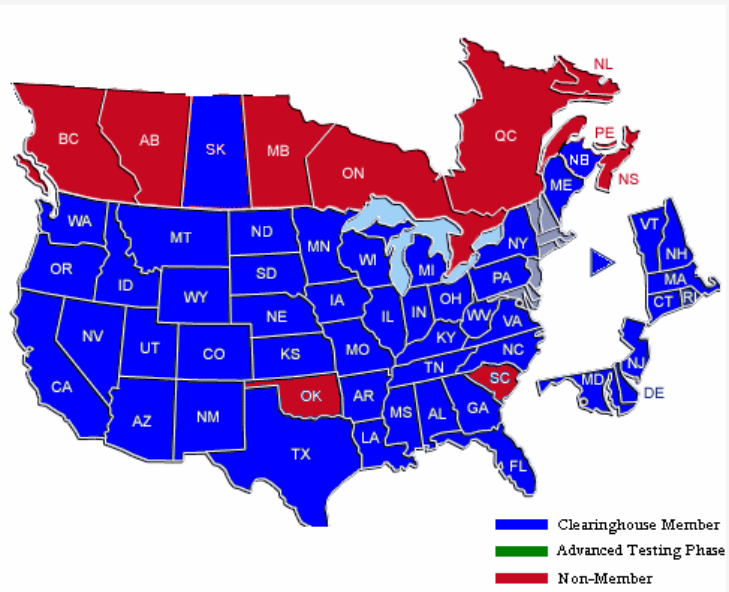
Funds Netting

For the rest of the year we will be testing Funds Netting on a monthly basis. All data is going to be treated as if all jurisdictions are fully participating in monthly funds netting. This is just a data test, actual money will not be transferred at this time.

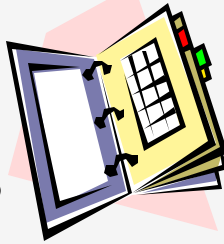
We strongly suggest you start looking at the funds netting tests monthly to get a grasp of the data now available to you.

For the February transmittals we did have a jurisdiction that missed the cut-off date, as indicated by the new funds netting calendar. We are treating the late jurisdiction as if this was actual production data. So in this case, the late data did not make it in time for the 2009-02 funds netting run. Their data will appear in the 2009-03 run as indicated in our funds netting rules which are currently under review by the IFTA Commissioners in your jurisdiction.

January 31, 2010 will be our first real transmittal run so please take the time to look at your data and make sure IFTA, Inc. is doing our work correctly.
