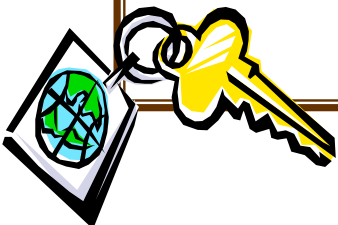

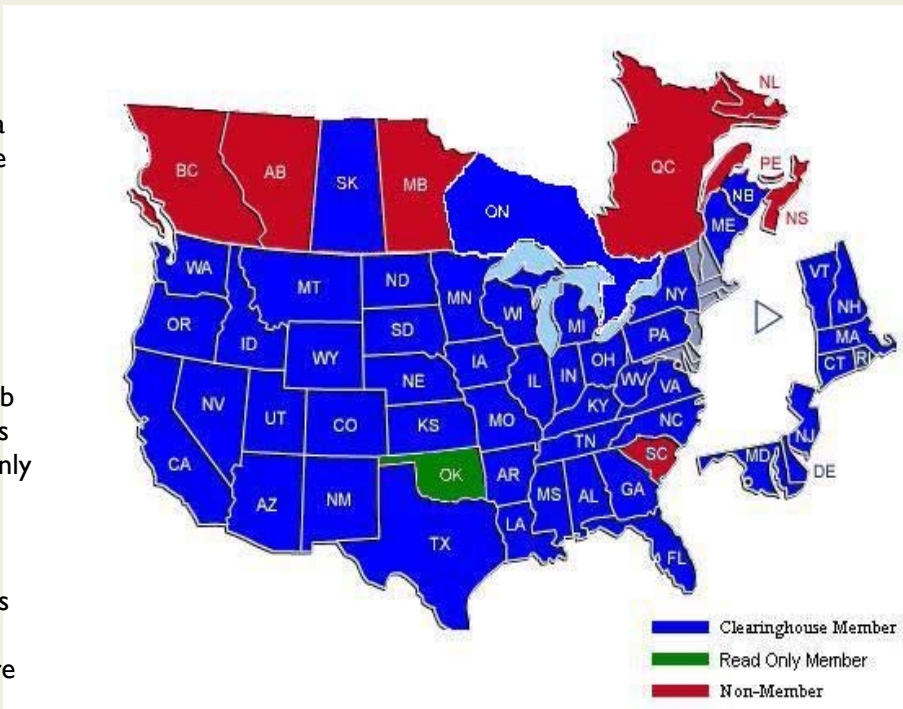

### Some New Features...

On the Funds Netting page a new link was added; it's called 'Transmittal Detail Download'. This is a text file of all the Transmittal Details based on the funds netting calendar and grouping for the funds netting period.

The reason for this file is that there was a special request for netting based on fuel types. It was decided that we are not going to create such a netting report but jurisdictions are allowed to grab all the detail records and create their own reports based off the details. In funds netting IFTA, Inc. only works with Summary Totals and all numbers are based off that file.

We also added the ability for you to look up IAR's using the name of the file. This may help you in searching the files you have uploaded to make sure they are there.
