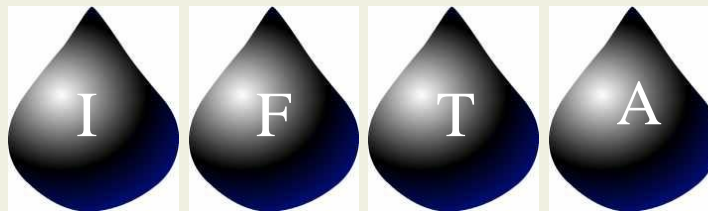

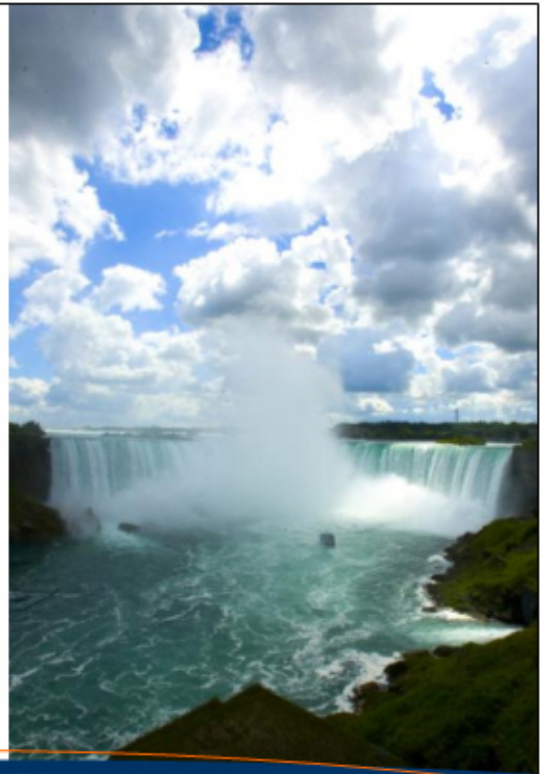

The Agreement Procedures and the Law Enforcement Committee have an informative agenda planned.



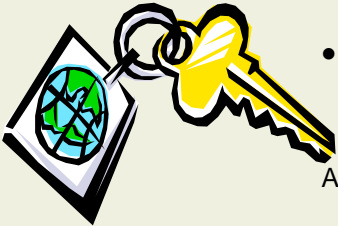

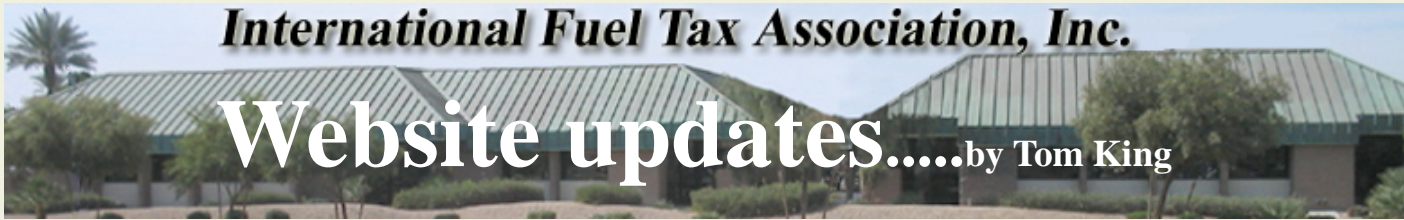

The first comment period for the four (4) 2010 Full Track Preliminary Ballot Proposals has ended. The comments have been posted to the IFTA, Inc. website on the Ballot Summary page.

After the first comment period, sponsors had a chance to revise their ballots prior to the Annual IFTA Business Meeting in Toronto, Ontario Canada in July. Ballot 3-2010 has been withdrawn by its sponsor following the first comment period. Revisions have been made to Ballots 1, 2 and 4. Additionally there has been a submission of a Short Track Ballot, #5-2010. Now with a click of the button you'll be logged out and then automatically logged into another section! Below is an example of what you might see if you have four accounts.



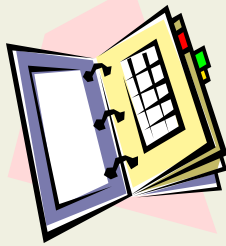

Demographic Data

Remember the demographic data on the Clearinghouse? With all the transmittal data and funds netting it may be easy to forget. The CAC (Clearinghouse Advisory Committee) will be reviewing demographic data and I have already looked through the data for possible errors. I have identified 23 jurisdictions that are sending incorrect data in regards to the official field definitions. After our next CAC call, on June 17th, these errors will be distributed to the affected jurisdictions with a due date as to when we would like to see the data fixed. Bad data in, is bad data out. I can tell you this, most of the data is just fine. It's the formatting of the Date Fields that are the biggest issue at present. With the date properly formatted we will be able run a lot more reports based on dates which could be helpful to most jurisdictions.

There are no new jurisdictions to report that are using the Clearinghouse. South Carolina is very close to uploading data into the Clearinghouse and becoming a full participant.
