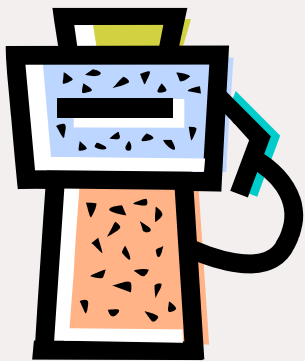

**# 5 - ONTARIO**

Where biodiesel is blended with fuel, only the biodiesel portion of the blend is exempt from tax. Licensees may apply for a tax refund directly to Ontario for the biodiesel portion and other tax exempt products such as methanol.

Thanks to those jurisdictions that have offered comments on the ballots. There is still time for the remaining jurisdictions to comment.

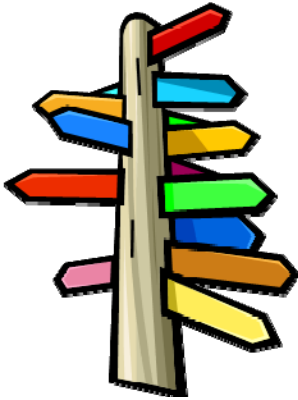
The First Comment Period for the Full Track ballot proposals will come to a close on [Friday, June 17, 2011.](#)

**Often Heard Questions**

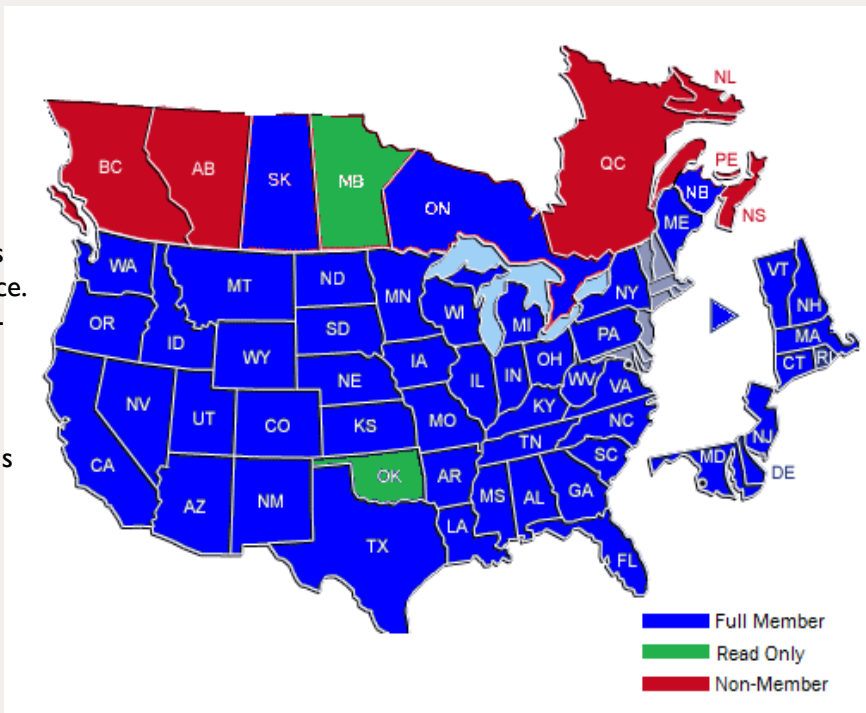
Are the Funds Netting numbers issued on the last Wednesday of the month?

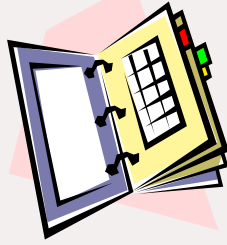
So while it may look like Wednesday is the day for Funds Netting it's not always the case. Please always review your Funds Netting Calendar for the precise dates for Funds Netting.
