

#### Call for Canadian Jurisdictions

As a reminder, the IFTA, Inc. Clearinghouse does allow for read only access to the Clearinghouse. Since all USA Jurisdictions but one have joined the Clearinghouse, this is a request for Canadian Jurisdictions to sign up for the Clearinghouse with read only status. This means you don't have to send information, but you will be able to view the data.

#### Immediate Benefits:

- Transmittals in Electronic format; data entry of transmittals is no longer needed.
- Access to the revoked demographics listings for when you sign up new carriers.
- Dozens of reports designed around jurisdiction needs.
- Relieve your fellow jurisdiction from sending paper which you eventually have to put in a file cabinet anyway.
