We sent out a request last month asking if you would like IFTA, Inc. to also include 'Suspended' Carrier Accounts along with the Revoked Carrier Accounts. Thank you for your quick response. The results are as follows:

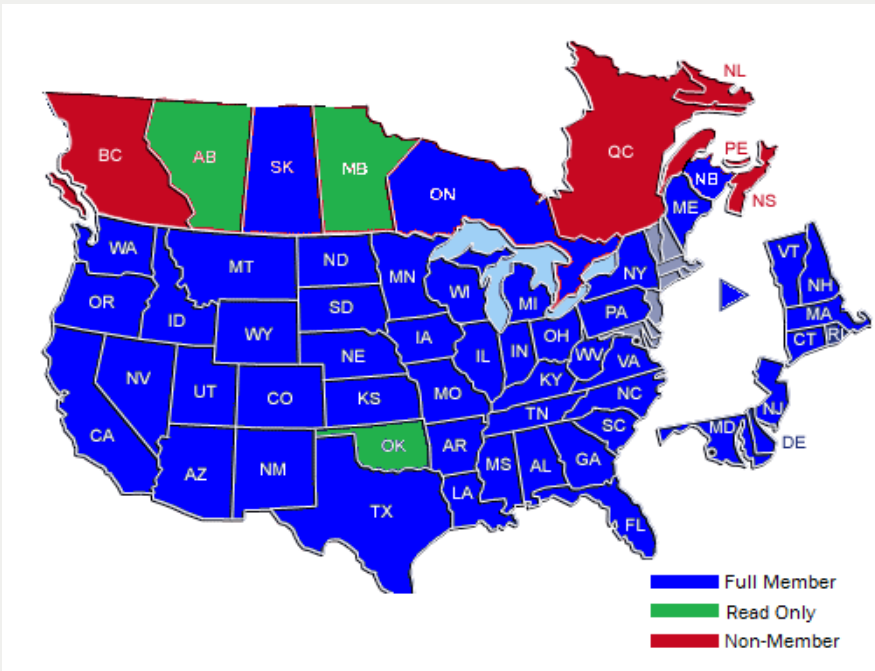
Our most Frequently Asked Question this month...how do I add a user, remove a user, change a user on my e-mailing list?

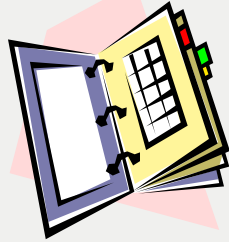
Ok, that's a few questions, but they always seem to come up.
