#### User Sign-up and Deletion

Just a reminder that all potential users of the IFTA, Inc. Clearinghouse, need to be registered on the <a href="https://www.iftach.org">www.iftach.org</a> web page. This requires a Level 5 user or above, typically your IFTA Commissioner or Office Supervisor. From the registration page you also have the choice to remove any users no longer with your organization. Please take a moment to review your current user database and make any appropriate changes.

#### **Canadian Read Only Option**

As you can see from the map below we only have a few Jurisdictions not yet participating in the Clearinghouse. We offer a read only option that does not require you to send any data at all to the IFTA, Inc. Clearinghouse. The benefits are numerous just to read only members.

You will get your monthly Transmittals in electronic format, no more paper, no more data entry. Do you need more incentive?

Check the IFTA status of any new applications using the Demographic Data base. Not enough incentive?

Run numerous reports that give you statistics based on carrier activity in your jurisdiction.

And as a final incentive, you will be using the latest technology.
