Inter-jurisdictional Audit Reports

The IAR page has been updated to include a delete function for the Audit Reports.

If you go to the search page you will find that item number 7 (at the bottom of the page) is new and is used to delete erroneous uploads.



In order to delete any files you will first have to search for your base jurisdiction and the year and month of the upload. Once the new page loads with your files, you are offered the option to delete that file. You also must be the user that uploaded the file for the deletion to occur.

I will still delete files manually if needed. But now you have the option to quickly remove the files.
