


Updating Your JCL

Have you been updating your Jurisdiction Communication List? If so have you been updating correctly? IFTA, Inc. has been noticing that not all jurisdictions that make changes to their JCL have done so correctly. While we appreciate the updates it is highly important that, when you change the information on the FIRST PAGE of your communication list, you also change the information on the SECOND PAGE of your communication list. This requires jurisdictions to complete information in one section (Edit General Information) as well as requiring jurisdictions to complete the "back" (Edit Mailing Addresses) section as well. Doing this ensures other jurisdictions will be able to view and maintain the most accurate information.

For example, if you look at the below snap shot you'll see that the jurisdiction updated one section of their JCL but they failed to click on the "Edit Mailing Addresses" and left the old information. Or... could it be they updated the Mailing and forgot to update the Commissioner's information on the first page? When the data conflicts like this the point is the same. Other jurisdictions viewing the data do not know, with certainty, which block of information is correct. So please! Remember to view your ENTIRE JCL so that you are updating ALL the information accurately. Thank you!

WEB SERVICES

The IFTA, Inc. Clearinghouse is now ready to start processing web service requests.

A web service is a mechanism where a user/program may contact a web page and receive data. The user will have to programmatically create a mechanism to call for and receive data from the web service.

An example of this process is something we have been doing by sending data to NLETS. NLETS users have specific screens from which information is pulled from NLETS when a request for a Tax Payer ID is made. When the Tax Payer ID is entered by road side enforcement, a request is made to NLETS. NLETS then requests the data, through web services, from IFTA, Inc., to see if that Tax Payer ID is also listed as Revoked.

Our first web service will be something close to what we do with NLETS. Serving to users Demographic information based on web service requests.



Web Services will not be something you will be able to do without your IT Department. Please inform them of this service and think of ideas on how to share data with web services for future reports.
