Upcoming IFTA Meetings






Mark Your Calendar!

Short Track Ballot 5-2014 did not received a sufficient number of votes to pass or fail. Here is the voting breakdown:

NUMBER OF "YES" VOTES RECEIVED: 34

NUMBER OF "NO" VOTES RECEIVED: 7

NUMBER OF VOTES **NOT** RECEIVED: 16

RESULT: FAILED

An affirmative vote of **at least three-fourths** of total member jurisdictions is required for any ballot language to pass. Three-fourths = 44 **AFFIRMATIVE VOTES.**

SAFER UPDATE

SAFER is still in the process of testing data. We sent them test/production data about 3 weeks ago from a member jurisdiction who volunteered. But, we haven't heard back from them. Meanwhile, Lonette Turner has completed the MOU for jurisdictions to sign to give us permission to send the data. There are 12 jurisdictions involved who had accepted this over a year ago when the project first started. So we expect little else to get in the way to complete this project.

Update: As I wrote this SAFER has contacted me stating some of the testing is complete. So there is some progress happening!
