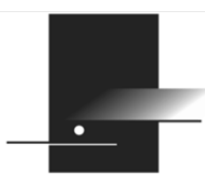

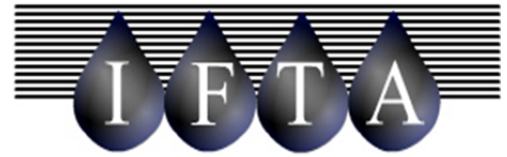
Upcoming IFTA Meetings

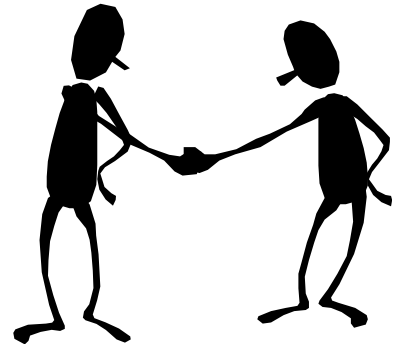

SAFER UPDATE

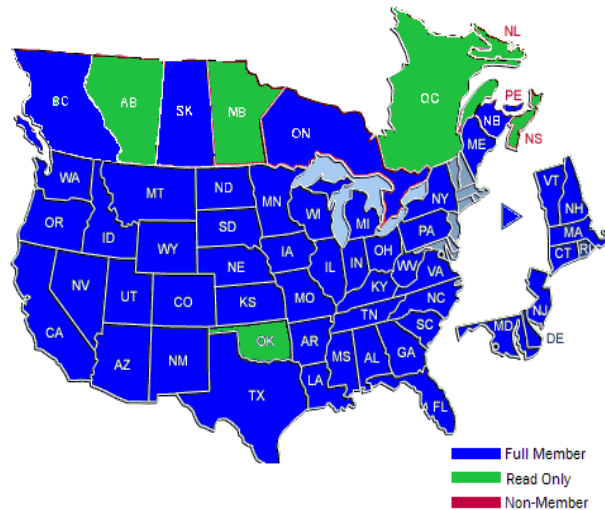
SAFER continues to work with the Clearinghouse Demographic data as provided by the jurisdictions. We are making available to SAFER a flat file of data which they are converting to XML to populate their database.

BAD DATA PROCEDURE

If there is ever bad data in regards to transmittal or summary data, you will need to notify myself or IFTA, Inc. as soon as possible. We will need to remove that data manually.

Only 1 upload of Summary Data for a transmittal number and year is allowed into the database. But it is possible for any number of transmittal details to be duplicated. Since funds netting is strictly based on Summary Totals, and Summary Totals can't be duplicated, Funds Netting will always be in good standing.

Duplicate Transmittal Details will affect reports and downloads. So please be aware if you see data that looks suspicious, contact us right away.
