

# 4Q 2014 ITEMS FROM THE BOARD

The IFTA, Inc. Board of Trustees held its Fourth Quarter 2014 Board meeting at the IFTA, Inc. offices October 21 - 22. All Board members were present and a couple of guests were also in attendance. During this two-day meeting many relevant issues were addressed. Some of these matters included, but were not limited, to the following:

- Minutes from the 2Q14 Board meeting were approved as amended.
- Minutes of the Board actions by Email during April through September 2014 were approved.
- Minutes from the Board meeting following the Annual IFTA Business Meeting were approved.
- A Consent Agenda consisting of committee reports was approved.
- Mr. Eric Belford (MT) was approved as the Western Region representative on the Law Enforcement Committee effective 11/1/14.
- Lt. Jennifer Brown (AZ) was approved as Ex-Officio to the Law Enforcement Committee following the conclusion of her term as committee Chair effective 11/1/14.
- Inspector Andrew Markle (ON) was approved as Chair of the Law Enforcement Committee effective 11/1/14.
- The Board approved the addition of four new fuel use types to the IFTA Clearinghouse as
  proposed by the Clearinghouse Advisory Committee. These new fuel types will be identified as
  DL, DLG, DC, and DCG. Training webinars regarding the reporting of dual fuel vehicles on IFTA
  returns and utilizing these fuel types will be completed and scheduled.
- Several updates have been made to the IFTA Clearinghouse including, but not limited to, new distance reports, a yearly stats page based on fuel use, return types, tax and distance.
- IFTA, Inc. is investigating a way to track amended returns in order to locate the original return through the Clearinghouse.
- Nova Scotia anticipates being a full participant in the Clearinghouse by the end of 2014.
   Manitoba and Oklahoma are working towards becoming a fully participating member of the Clearinghouse by the end of 2015.
- IFTA, Inc. is ready for the single funds netting disbursements beginning January 2015.
- The Board approved the 2016 Funds Netting Calendar.
- Meeting materials have been posted to the website from the September 2014 IFTA Attorneys'
   Section Meeting as well as the August 2014 Annual IFTA Business Meeting.
- IFTA, Inc. is working to allow the message board to work with all browser types including Google Chrome. Uploading files is still being worked on.
- The tax rate calendar through to 2016 has been updated and is available online.
- The Board approved the 2016 decal specifications.

- The Board approved Mr. David Nicholson (OK) as Chair of the IFTA Audit Committee effective 11/1/14.
- The Board approved Mr. Ed Beaudette (MT) as Chair and Ms. Sukanya Mukherjee (MD) as Vice Chair of the IFTA Attorneys' Section Steering Committee effective 11/1/14.
- Prince Edward Island is currently undergoing their 2014 Program Compliance Review (PCR).
- Review dates for 2014 have been extended as a result of several jurisdictions having new staff members.
- The 2015 PCR schedule is complete and it is expected that all reviews will be completed electronically
- Webinars for PCR reviewer training and jurisdiction review expectations will be completed by IFTA, Inc. in the near future.
- The Program Compliance Review Committee (PCRC) has withdrawn IFTA FTPBP 1-2014 which would have reduced the IFTA program compliance review cycle from five (5) to four (4) years. The committee withdrew this ballot following the discussions at the Annual IFTA Business Meeting. As a result, the PCRC has realigned the review schedule creating a fifth region: the Canadian Region. Some Provinces will undergo interim reviews in 2016 to put them on the Canadian review cycle. The committee has contacted the Canadian provinces to explain the scope of these interim reviews. IFTA, Inc. will issue a memorandum to membership explaining the realignment and the addition of the fifth region for the purpose of reviews.
- During the Board meeting a conference call was held with the IFTA committees and working groups. Reports were offered by either the Chair or Vice Chair of the:
  - Agreement Procedures Committee Ms. Kimberly Knox-Lawrence (ME)
  - Audit Committee Mr. Jeff Hood (IN)
  - Dispute Resolution Committee Mr. Mark Byrne (NE)
  - Industry Advisory Committee Ms. Sandy Johnson (North Star Fleet Solutions, Inc.)
  - Information Technology Advisory Committee Mr. Thom Rabaglia (WI)
  - Program Compliance Review Committee Mr. Joe Dian (IN)
  - Attorneys' Section Steering Committee Mr. Collin Davis (IN)
  - Dual Fuel Working Group Mr. Hugh Hughson (BC)
  - o IFTA Compliance Working Group Mr. David Nicholson (OK)
  - Clearinghouse Advisory Committee Mr. Randy Boone (IN)
- The committee charters and member terms were also discussed with the committees during the
  conference call. It was the opinion of the Board to revisit this issue during the 1Q15 Board
  meeting so that the Board and committees had more time to review and comment on the various
  changes to the charters and member terms.

- The Board approved the registration fees for the 2015 IFTA/IRP Audit Workshop at \$305 for member jurisdiction representatives and \$355 for industry and general public representatives.
   Additionally, Exhibitors registration fees are \$700.
- IFTA, Inc. will research the financial impact of paying full committee expenses for the Audit
  Committee, the Agreement Procedures Committee and the Law Enforcement Committee for the
  two workshops and will present these figures to the Board for the next budget cycle.
- The Board approved hosting the 1Q15 Board meeting face-to-face at the IFTA, Inc. offices in February 2015.
- It was recommended by the Board that the Attorneys' Section Steering Committee consider
  hosting future meetings in conjunction with other meetings such as the Audit Workshop or the
  Annual IFTA Business Meeting. This is to minimize any out-of-pocket organization expense for
  attrition or hotel expenses.
- Mr. Pitcher informed the Board that the Industry Advisory Committee has created a
  subcommittee to discuss electronic credentialing. This group will research the issue of electronic
  credentials and then present it to membership as an option to repealing the IFTA decal
  requirement. The focus of this subcommittee is to address the following:
  - What does industry want in an electronic credential
  - What are the functions of an electronic credential
  - What types of things are necessary now
- The Board reviewed the Annual IFTA Business Meeting and discussed the completed evaluation forms from the meeting.
- 2014 ballots were discussed:
  - FTPBP #01-2014 withdrawn by sponsor following the Annual IFTA Business Meeting
  - FTPBP #02-2014 out for the second comment period
  - o FTPBP #03-2014 out for the second comment period
  - FTPBP #04-2014 out for the second comment period
  - STPBP #05-2014 IFTA, Inc. will reformat this ballot and present it to the sponsor (Board) for approval prior to its release for vote
- The IRP ballots for 2014 were also reviewed. These ballots included:
  - IRP Ballot 391 Apportionable Vehicles passed by 90%
  - o IRP Ballot 392 Inadequate Assessments failed by 46%
  - o IRP Ballot 393 through 398 Board Elections Mr. Robert Ide, Mr. John Poole, Mr. Jeff Hood (IN), Mr. Shaun Hammond, and Mr. Peter Hurst have all been elected to serve on the IRP Board of Directors
  - IRP Ballot 399 Board Election Re-vote This ballot is open until November 3, 2014 for voting for the Region IV (US) representative to the IRP Board of Directors

- The Board also discussed the IFTA, Inc. Contingency Plan. IFTA, Inc. is drafting a "white powder" plan. Additionally, it was considered that IFTA, Inc. should draft a continuity plan for when a jurisdiction becomes incapacitated for a period of time, how that would affect membership, and what IFTA, Inc.'s. role should be during that period of time.
- Concerns were addressed regarding ballot passage and how a non-voting member can affect
  the outcome of a ballot proposal. As a ballot requires 44 affirmatives to pass this was
  considered a moot point and not an issue of concern for the Board to address at this time.
- The creation of an industry access web page through the IFTA, Inc. website was considered.
   IFTA, Inc. will look into what type of information should be provided on this page and what the expense would be to provide it to industry securely.
- The Board reviewed the IFTA, Inc. financial report and was informed that the organization remains financially sound.
- The financial statement audit was recently completed by the auditors from Lumbard and Associates. The auditors will be returning to IFTA, Inc. to complete the SOCII audit in November.
- The Board was informed that the rental contracts remain in good standing and that the end unit,
   B-3, halfway through their 36 month lease agreement

During the meeting the Board met in closed session with the IFTA, Inc. Financial Advisor, Mr. Joshua Waitz, J.P. Morgan Securities, Chase Private Client, for the purposes of discussing the organization's investments.

After the agenda items were completed, the Board held a Strategic Planning Session. During this session the Board reviewed the goals and objectives completed during the 2Q14 Board meeting and began writing action plans. This Plan will continue to be reviewed and amended by the Board during the next few Board meetings in 2015.
