CHANGES AT IFTA, INC.



NEIGHBORHOOD SPOTLIGHT

The Inside Scoop From Your IFTA Neighbor...

ONTARIO

It all began 33 years ago in January with three jurisdictions and a vision. But before it became a reality it was nothing more than an experiment. In 1982 representatives of the States of Arizona, Iowa and Washington expanded discussions of uniformity for motor carrier fuel use tax reporting to an agreement known as The International Fuel Tax Agreement (IFTA). From a humble experimental beginning the IFTA grew into the successful program that we all follow and benefit from today. Through this forum and series of interviews it is my goal to provide an opportunity where we can all get to know each other on another level both professionally and personally. I hope that you will join me as we strive to get a closer look at those implementing, working and improving the IFTA as a whole.

Our first interview takes us across the borders, out of the country, and into a beautiful province in Canada: Ontario.

WHEREAS, the International Fuel Tax Agreement was formed to provide a uniform system for the licensing and payment of fuel taxes by interjurisdictional motor carriers; and... on behalf of the Province of Ontario does hereby ratify the Agreement.

That was the beginning of Ontario's official start in the IFTA which was implemented January 1, 1997. Ontario was the tenth Canadian Province to join the IFTA and brought membership to a total of 58 members. Over the course of the years Ontario remained active in the IFTA and keeps in contact with its fellow jurisdictions. Ontario also meets monthly with its Canadian delegates by conference call to keep up to date with occurrences and questions affecting their IFTA program.

Ontario is a strong supporter of the IFTA; they have had much representation on the various committees, attended multiple meetings and workshops, and have sat on the IFTA, Inc. Board of Trustees. Our Board President, Mr. Ronald Hester, is employed by the Ontario Ministry of Finance. I had the distinct pleasure of speaking with Mr. Hester and this is what he had to share with me.

Ron Hester worked for the Ontario Ministry of Finance for sixteen years prior to his first appointment to the Agreement Procedures Committee (APC). Mr. Hester served on this committee from January 2005 to September 2009 and became Vice Chair in September 2007. When I asked about his time on the APC, Mr. Hester had the following to say:

"We had a great team on the committee and got to know each other through our many conference calls and coming together at the IFTA Managers' and Law Enforcement Workshop. Not only did I learn a lot

about IFTA, but working on the APC enabled me to enhance my skills, all the while developing some great friendships. I believe the experience you get from serving on an IFTA committee is in-valuable and I wouldn't trade the experience."

Reflecting back to his earliest memories of the IFTA, Mr. Hester recounted when Ontario was working towards becoming a member. He went on to say that when they were training on the IFTA program, as well as on a new mainframe IFTA system, one of his earliest impressions was that it would be a lot of work processing the returns because their clients would be reporting for all their travel. "The IFTA concept was a totally new one for us in Ontario. It's amazing how far we have come since those initial days in IFTA and how much we have learned and hopefully grown since."

We then began to talk about his term on the IFTA, Inc. Board of Trustees. When I asked if he had ever envisioned himself as the President, Ron smiled and laughed. He had thought of serving on the Board and felt that it would be a great opportunity. Ron was thrilled and honored when his name was submitted and he was then elected to serve on the Board. "I am humbled to follow in the footsteps of many great Board Presidents and feel it is a great responsibility which I take very seriously."

Taking this opportunity I asked Mr. Hester that, if he had just one message to share with the membership, what would that message be? What follows is his heartfelt response.

"I believe that IFTA is a real success story, a model to be proud of and one that other organizations can aspire to. The success of IFTA is due, to a large extent, to the cooperation and working relationships that exist between jurisdictions as well as between jurisdictions and industry. I encourage jurisdictions to continually stay involved with IFTA by participating in the various committees, working groups and the Board; to send representatives to each of the various workshops held during the year as well as the Annual IFTA Business Meeting; and to comment and vote on the various ballot proposals throughout the year. So it's really all about continuous participation and involvement in IFTA in order to impact positive change for the betterment of all our jurisdictions in the area of Fuel Tax administration."

When I asked about the IFTA program in Ontario, Mr. Hester smiled and thought about all those within the Ministry of Finance that help to make it the success it is today. "This is due to the great team of folks that we have working on the program at various levels and functions. We have very dedicated folks here that provide excellent customer service from the registration and renewal process through return processing, tax advisory services, to audit and inspection activities." Mr. Hester went on to acknowledge the information sharing that Ontario ensures across the province. "This information sharing includes regular updates from any of us that attend various IFTA meetings so that all of our folks are up to date with the latest IFTA happenings." This sharing of information is a means to guarantee all departments and personnel are kept up to date on IFTA related activities. Ontario continues to look at what the most efficient model might be to effectively deliver their services related to the IFTA program to their clientele. Ontario is also reviewing a succession plan in order to maintain the historical and ongoing working knowledge of the IFTA program in its province. Mr. Hester feels proud to work with such a great team and be involved in the great program known as IFTA.

I had the chance to inquire as to what Ron felt was one of IFTA's finest qualities. He commented on the cooperation and trust that exists between jurisdictions as well as jurisdiction to industry. While the IFTA remains one of the soundest models currently being followed, Mr. Hester felt that the community as a whole could rise to any challenge if we remain true to the core mission and vision as well as continuing to work together as partners, jurisdictions with industry.

Ron Hester is a Tax Administration Manager and has worked with the Ontario Ministry of Finance for over twenty-five years. Commenting on those he works with he exclaimed that they are a "great team of folks here." Ron works on many commodity taxes, including IFTA, of which he has a real passion for. Around the work place his fellow team members even call him Mr. IFTA. He shares his life with his wife of fourteen years, and his children, Lucas, who is ten, and twelve year old Alyssa. "Several months a year, you'll find my wife and I busy shaping and re-shaping our ever changing perennial gardens which we find very peaceful and rewarding after a long day at work.

"While we enjoy gardening, we are full-fledge Christmas fanatics and love the whole season. We begin with Christmas music at the end of the summer season, while decorating for Christmas begins immediately following the Thanksgiving weekend – Canadian Thanksgiving that is – yes you heard correctly! We also collect, set-up and display lighted Christmas villages throughout our home and over the past few years we have opened our home as part of a Christmas house tour in support of a local charity. Some may call us 'crazy', but we find it all very relaxing and enjoyable. Our home is complete with everything except real snow on the floors (that we leave for outside)."

In concluding our interview, I asked Ron if he felt the IFTA program was working or if there might be something he would look to change. His response is shown below.

"I do feel the IFTA program is very beneficial. I think of what existed prior to IFTA in all of our jurisdictions, and I believe we have come a long way and wouldn't want to return to that prior model. We have developed a model organization that suits both, jurisdictions and industry. What would I change about the IFTA program? Hard to pinpoint exactly, but I believe we will continue to strengthen the IFTA through great insight and suggestions from us as members as we move forward together."

With his Board of Trustees hat in place, Ron went on to say that "the Board is currently working on revising the IFTA, Inc. Strategic Plan and we are hoping that we will be able to pursue opportunities to enhance the IFTA program that will further benefit all of us as members. I would encourage everyone to send any suggestions in this area to myself or to your Board liaison."

I really enjoyed my conversation with our Board President, Mr. Ron Hester. He was forthcoming and answered even more questions and points than I was able to include in this interview. Both Ron and I hope that we can reach out to more members and offer you their thoughts and insights to the IFTA within their jurisdiction as well as the IFTA model as a whole and how it affects each one of us. For now I would like to acknowledge and thank Ron for his cooperation and patience in collecting the information for this article.
