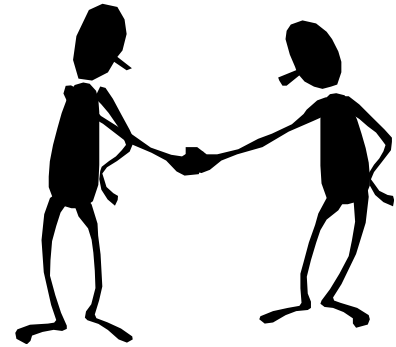

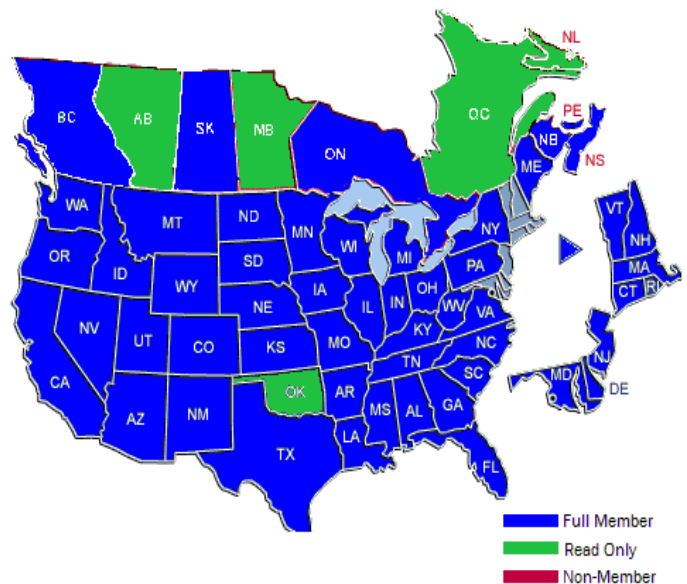

On the SFTP server we offer a variety of files for download. Our latest file is called 'iftalessdemographics.txt'. In this file we have all the demographic records containing taxpayer id, jurisdiction, status, status date. This file is comprised of 900K carriers. We also have various other files, like the full demographic database in zip format, a file listing all revoked carriers or active or cancelled a file that just contains the taxpayer id and status, and many more. If you would like to get this files please visit the demographics web page to manually download them, or uses the SFTP server to automatically retrieve these files on a daily basis.
