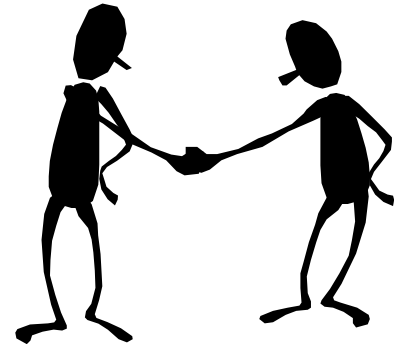

Sorry about our mess as we make this transition.

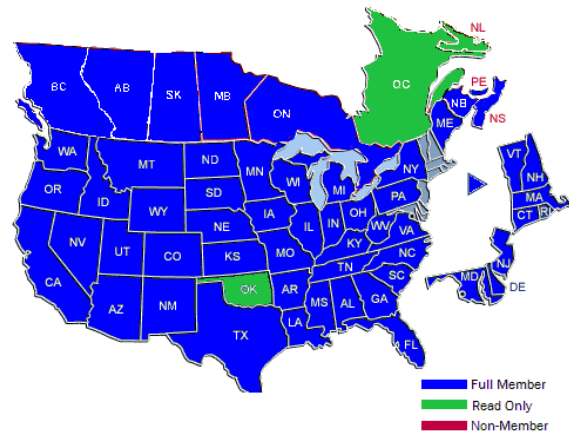
