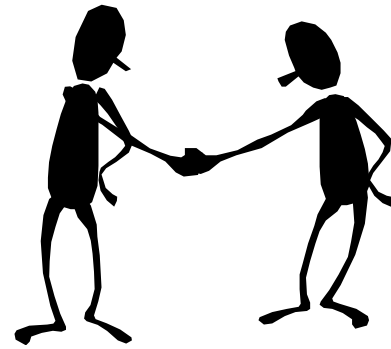

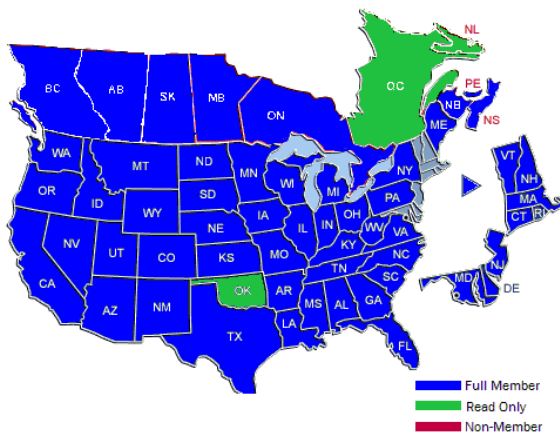

## Clearinghouse Usernames and Passwords

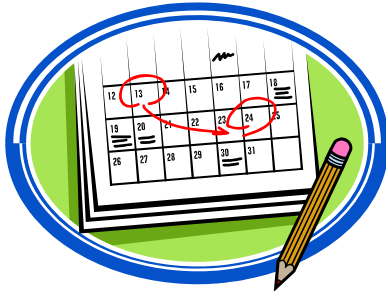
Forgot your username or password? Use the username and a password recovery feature found on the log in pages for both demographics and transmittal.
