IRP Clearinghouse

- In 2017, over \$945 million dollars were exchanged through the IRP Clearinghouse.
 - This is an increase of over \$110 million over 2016
 - A major part of this is Oklahoma joining the CH
 - This represents only the funds netted and exchanged between the 57 IRP jurisdictions that currently participate in the Clearinghouse
 - Estimated that over 2.9 billion dollars is generated by IRP registrations annually
 - There were over 2.6 million IRP vehicles registered in 2016
 - Waiting for IRP Annual Activity reports currently to see what he numbers for 2017 were

IRP Clearinghouse

- IRP Clearinghouse Standardization Project
 - We are currently working with jurisdictions to standardize the data in the Clearinghouse
 - This project is to ensure that all data needed by jurisdictions to adequately verify other jurisdictions are properly calculating fees is provided and to ensure that necessary data is being provided by all jurisdictions
 - The go live date was January 1, 2018, with many jurisdictions participating
 - Others will be phased in as they are ready

Education and Training

- IRP, Inc. is working with IFTA, Inc. staff to determine if we can do this project jointly.
- Goal is to provide an online training tool, which will provide the same look and feel of the product for both memberships.
- There are other benefits, but the primary focus is to provide a good product that can meet the needs of our joint memberships.
- Still working on the evaluation, working with a group of jurisdictional volunteers, of the fraud training products offered by AAMVA to determine what fits well for the motor carrier services community and what might need to be developed to best meet the needs in that arena.
