HIGHLIGHTS from the BOARD 4Q 2020

On October 6 - 8, the IFTA, Inc. Board of Trustees (Board) met for the Fourth Quarter 2020 Board meeting. Due to the COVID-19 pandemic, this meeting was held virtually.

All nine Board members were present. Guests included Mr. Tim Adams, IRP, Inc. CEO, Mr. Drew Clark (KY), Clearinghouse Advisory Committee 2nd Vice Chair, Ms. Tammy Day (IN), Electronic Records Standardization Working Group Chair, Mr. Scott Greenawalt (OK), Dispute Resolution Committee Vice Chair, Mr. Omer Guzman (MI), Dispute Resolution Committee Chair, Mr. Jeff Hood (IN), IRP, Inc. Board of Directors Chair, Mr. Robert Pitcher, Consultant, Ms. Joni St. John (NS), Agreement Procedures Committee Chair, Ms. Cindy Swanson (CA), Agreement Procedures Committee Ex-Officio, and Mr. Dennis Vanderslice (ARI Fleet), Industry Advisory Committee Chair.

Below are some of the highlights from this three-day virtual meeting.

- The Board Actions via Email and Conference Call were approved.
- The Board tabled the discussion regarding the 2021 IFTA/IRP Audit Workshop until the First Quarter 2021 Board meeting.
- Learning Management System (LMS)

TotaraLearn is the platform that would be utilized for the Learning Management System (LMS) and EClass4Learning is the vendor that would support this platform.

A draft of the Memorandum of Understanding (MoU) was provided to the Board and the organization's attorney for review and outlined the agreement between both IFTA and IRP and clarifies the responsibilities and expenses to both organizations. Once the MoU has been approved, the vendor contract could then be presented for consideration.

- The Board approved the funds netting calendars as prepared for 2022 and 2023.
- IFTA, Inc. Audits

IS Partners were accepted as the IFTA, Inc. SOC auditors for the next three years as presented by IFTA, Inc.

A financial audit is currently underway for the fiscal years 2018, 2019, and 2020 and is anticipated to be completed prior to the end of the year.

2021 Meetings

The Board approved planning for a hybrid event for the First Quarter 2021 IFTA Board meeting. This event will be scheduled for February 9-11.

The Second Quarter 2021 IFTA Board meeting is currently scheduled as an in-person event at the Sonesta Resort in Scottsdale, AZ for April 20 - 22.

The Third Quarter 2021 IFTA Board meeting has not been officially scheduled but could be aligned with the Annual IFTA Business Meeting at the San Diego Marriot Mission Valley hotel in San Diego, CA on August 18-19.

The Fourth Quarter 2021 IFTA Board meeting will be considered during the First Quarter Board meeting.

- The election of the Executive Committee of the Board was held. The results of this election were as follows and will be effective as of January 1, 2021:
 - Treasurer Mr. David Nicholson (OK),
 - Secretary Ms. Helen Varcoe (MT),
 - o Vice-President Ms. Antoinette Tannous (QC), and
 - President Mr. Scott Bryer (NH)

Committee Update:

The APC created a subcommittee to address the Board charge of investigating the modernization of the ballot procedures. The subcommittee presented recommendations resulting from this charge.

The Clearinghouse Advisory Committee (CAC) has been working on the Board charges one of which was to provide clear direction in support of the modernization of the Clearinghouse. Two platforms, NetCore and PHP, were presented in this regard.

The Board had charged the DRC with reviewing the Dispute Resolution Process (DRP). The timeline for this charge was amended by the Board to permit the committee more time to complete its research and provide written recommendations for the First Quarter 2021 Board meeting.

The Board directed the PCRC to allow jurisdictions to utilize the options presented and approved at the Annual IFTA Business Meeting regarding the 3% audit requirement for all PCR conducted in the years 2021 through 2025. These options were to either omit 2020 or include 2020 in the 3% audit requirement.

- The overall organizational financial budget and the investment portfolio remain financially sound.
- An IRP/IRP, Inc update was provided by Tim Adams, CEO.
- A recommendation to increase the number of Board members was presented. When increasing the
 representation from nine to ten members it was explained that each region could then have two
 members on the Board.
- The Board moved to amend the Bylaws to expand the IFTA, Inc. Board of Trustees to consist of ten members with each region having two members. This change will become effective January 1, 2022.
- The Board was apprised of the progress with the various Strategic Plan action items and ongoing items of interest were reviewed.

Working Groups:

An Alternative Fuels Study Group was charged by the Board in December 2019 to conduct research and provide guidance regarding alternative fuels. Due to the pandemic the group has not been able to meet in-person and requested an extension to complete the Board charges. The Board pushed the study out for an additional year, to be completed by the Annual IFTA Business Meeting in 2022, to assist the group in completing their research and creating guidelines.

The Electronic Records Standardization Working Group was established to review the format for the electronic data and provide recommendations for a standard format and analyze the electronic recordkeeping requirements in the IRP Plan and the IFTA Agreement.

Coming Soon: Online IFTA and IRP Training!

As part of our shared goal to provide high quality, topical training to our stakeholders IFTA, Inc. and IRP, Inc. have embarked on the creation of a shared learning management system (LMS). The yet-to-be-named LMS will provide training for members and industry associates/affiliates to provide a consistent source of educational content about IFTA and IRP topics.

This project kicked off on December 4th and we expect to launch the LMS in the Spring, 2021. Our committees and team members have started to prepare educational content, an endeavor that will continue long after the initial implementation.

IFTA, Inc. and IRP, Inc. solicited suggestions for names for the shared LMS. A naming announcement is expected by the end of the year.

In the coming weeks, jurisdictional members will be asked for some information about your team structures. We will be establishing jurisdictional hierarchies within the LMS to enable management to view the learning records of their team members. When these requests are made, please respond with the necessary details in a timely manner to streamline the implementation process.

Grace Period Memo - 2021

In early November, IFTA, Inc. posted the annual Grace Period memorandum to the website. A copy of this memorandum can be found by clicking here 2021 Grace Period Memo. This memorandum explains that "Carriers renewing their IFTA license and decals have a two-month grace period (January and February) to display the renewal IFTA license and decals. To operate in IFTA jurisdictions during this grace period, carriers must display either valid current or prior year IFTA license and decals from the jurisdiction in which they were operating or a valid single-trip permit from the IFTA jurisdiction in which they are operating."

So remember! To operate in an IFTA member jurisdiction (US or CND) during this two-month period, carriers must have either:

- 1) A valid 2021 IFTA license and two IFTA decals issued by an IFTA member jurisdiction.
- 2) A valid 2020 IFTA license and two IFTA decals issued from an IFTA member jurisdiction (provided a renewal application has been filed for 2021); or
- 3) A valid trip permit issued by the IFTA member jurisdiction through which they are operating.
