IFTA, Inc. Board of Trustees Minutes of Actions by Email July through September 2017

1) 2017 CHARLES M. MILLS AWARD OF EXCELLENCE

Debora K. Meise, Senior Director, IFTA, Inc. notified the IFTA, Inc. Board of Trustees (Board), by a post on its Message Board, that the Law Enforcement Committee had made a recommendation for the recipient of the award.

On August 31, 2017 Mrs. Meise set up a voting poll on the Board's secure message board to approve David Couprie (MB) as recipient of the 2017 Charles M. Mills Award of Excellence. Votes were submitted via the Board's secure page on IFTA, Inc.'s website and via email August 31 through September 11. The Board approved.

2) 2017 ANNUAL IFTA BUSINESS MEETING (ABM)

On July 19, 2017 Lonette L. Turner, CEO, IFTA, Inc. notified the Board that she had interviewed three futurists that could make a presentation at the 2017 ABM. She made a recommendation to the Board.
