This position is organizationally assigned to the Motor Fuel and Highway Funding Division of the Office of Highway Policy Information (HPPI), within the Office of Policy and Governmental Affairs (HPL), Federal Highway Administration (FHWA), U.S. Department of Transportation (DOT). The Office is responsible for supplying the national source of highway transportation data; providing the U.S. DOT, Congress, and transportation community with accurate information products in a timely manner to inform the development and implementation of decisions, policies, legislation, programs, and performance goals, while constantly striving to improve the efficiency and effectiveness of data collection and analysis on the physical, operational, condition, performance, and financial condition of our highway system.

The duty location for the position is Washington, D.C and is **telework-eligible**. Additionally, this position is **remote work-eligible** (for non-DC Region candidates only).

Position Information

The candidate selected for this position will serve as Manager for the Highway Use Taxation Programs responsible for conducting a wide range of coordination activities required for the administering of the Highway Use Tax Evasion (HUTE) program and related Discretionary Grant Program which aim to combat fuel tax evasion activities and ensure proper enforcement. This includes, but is not limited to, executing the grant application, review, selection, and award processes, and project monitoring activities. Additionally, the candidate performs a variety of tasks required for administering the Heavy Vehicle Use Tax (HVUT) compliance program including, but not limited to, coordinating annual state HVUT Proof of Payment certification submissions, and related program compliance reviews for enforcement purposes. Lastly, the candidate collaborates with motor fuel data quality reviews, analyses, and product development, and related exploratory research required to support policy and program development efforts.
