## INTERNATIONAL FUEL TAX AGREEMENT (IFTA) WAIVER OF IFTA CREDENTIALS EXTENSION OF IFTA 1<sup>ST</sup> QUARTER 2020 TAX RETURN DUE DATE

Manitoba has temporarily waived the requirement for IFTA credentials as well as extended the filing deadline for the IFTA 1<sup>st</sup> quarter 2020 tax return.

Effective immediately, Manitoba is waiving IFTA credentials (licence and decals) requirements for Manitoba carriers until July 31, 2020. Manitoba is requesting that agencies in other jurisdictions suspend enforcement action on Manitoba IFTA carriers travelling through their jurisdictions until July 31, 2020 if the vehicle operator does not carry a Manitoba IFTA licence or display IFTA decals.

The IFTA 1<sup>st</sup> quarter 2020 tax return that would normally be due on April 30, 2020 will now be due on July 31, 2020. Interest will continue to apply on all outstanding tax debts established prior to the April remittance deadline. Carriers will still receive paper returns in the mail or web notice reminders by email for returns.

Please note that the Taxation Division office is now closed to the public. IFTA carriers still wanting to obtain an IFTA licence or decals can do so by completing the [Application for IFTA Licence and Decals](#) or [Application for Additional Decals](#) and emailing the application to the Winnipeg office at [MBTax@gov.mb.ca](mailto:MBTax@gov.mb.ca). Please pay the applicable fees on [TAXcess](#). Once the application form and payment are received, the application will be processed and if approved, the licence will be emailed and the decals mailed to the carrier.
