#### JOB RESPONSIBILITIES:

This position is located in the Motor Carrier Services-IRP Audit Division with statewide duties in the areas of Darlington, Dillon, Florence, Marion, Marlboro, Lee or Chesterfield. Must reside in Florence County or be willing to relocate to Florence County. Must be willing to travel and occasionally perform overnight in-state and outof-state audits. Under limited supervision, conducts simple to moderately complex field audits of individuals, corporations and businesses licensed under the International Registration Plan (IRP) and the International Fuel Tax Agreement (IFTA). This employee is responsible for providing administrative and technical advice and assistance to South Carolina motor vehicle carriers.

#### **Job Functions:**

- 1. Conducts simple to moderately complex audits of individuals, corporations and businesses licensed in South Carolina to ensure compliance with the audit procedure guidelines of the International Registration Plan (IRP), the International Fuel Tax Agreement (IFTA), and SCDMV policy.
- 2. Prepares and submits comprehensive audit reports which fully disclose the basis for all proposed adjustments.
- 3. Assesses and counsels individuals, corporations and businesses participating in IRP and IFTA and those contemplating participation.
- 4. Complete account follow up as needed or as required.
- 5. Complete itinerary and daily activity reports as required by written instructions. Ensure these reports are submitted to the Department according to instructions.
- 6. Performs other duties as directed to include attending in-service training to improve understanding and maintain knowledge of IRP and IFTA.
