Dear IFTA Community,

With the elections over, there may be a feeling by some people that things may not have gone the way you thought they would. As the statement above says, with new challenges and new adversity, there are always opportunities for growth.

As we approach the closure of another dynamic year at IFTA, Inc., I want to take a moment to reflect on the progress we’ve made and to thank all of our stakeholders for continuing to participate and making our IFTA community stronger and more aware of the issues affecting fuel use taxes. Our collective commitment to innovation, collaboration, and enhancing the Interstate Fuel Tax Agreement continues to drive us forward.

Enhancing Collaboration

Over the past year, the IFTA Board of Trustees and the IFTA, Inc. Team have continued to work on expanding communication with our stakeholders and enhancing our major events to ensure a true educational and networking experience. In 2023 we created a Planning Committee to assist with the 2024 IFTA Educational Forum content creation collaborating with stakeholders from all different areas to ensure a true multifaceted educational event.

We have also embarked on the creation of a new strategic plan and created a Working Group comprised of various types of stakeholders to ensure every stakeholder has a voice into our next strategic plan.

We continue to expand and improve upon our quarterly Newsletter to provide open communication and informative information to our stakeholders.

Improving and securing our IT systems

We continue to review our IT systems for ways in which we can improve the user interface and enhance the data provided. We also took steps to ensure that our systems are not only using Best Practices but also that we have mitigated the risk that our systems can be

compromised. We recently underwent an IT System Penetration test by an outside consulting firm. During the course of this test, some very minor issues were identified as possible risks, and all of these items were changed and corrected. We retested and have obtained a certification that all of our systems are secure and passed the penetration testing.

Improving Efficiency

The team at IFTA, Inc. and the IFTA Board of Trustees are always looking for ways in which we can become more efficient, including more fiscally efficient.

In conjunction with the Board of Trustees, we created a Board Charge to have the PCRC create a subcommittee and develop a new Program Compliance Review Process that would drastically change the way in which we perform Program Compliance Reviews making the whole process more efficient and focused on the major items that membership cares about. We met in person this month and are making some great progress toward drafting a new process.

With the recent announcement by IRP that they are moving their Learning Management Modules to their own platform and away from the joint platform we shared, we had to look for a new platform which turned out to be a blessing. The new platform will actually save us a considerable amount of money.

We continue to review every transaction and every task for ways in which we can reduce costs and improve efficiency.

Advancing Sustainability Goals

As the transportation industry continues to evolve, IFTA, Inc., has also been at the forefront of addressing sustainability challenges. Our outreach efforts to stay informed of advances in alternative fuels and participate in various organizations' efforts to find alternative sources of sustainable revenue for infrastructure, is a high priority. We strive to convey what we learned to the IFTA Board of Trustees and our members so they can make informed decisions. While the change in the federal government administration may or may not delay some of the rules previously established by the EPA, the issues facing the sustainability of a revenue source for infrastructure will continue to be at the forefront of legislator's minds and we want to make sure that our IFTA community has a voice in future changes that will affect our cooperative agreement.

Improving our Cooperative Agreement

Part of our next strategic plan will be a comprehensive review of our Governing Documents to ensure consistency, accuracy, grammatical correctness, and opportunities for improvement. We also continue to discuss with our stakeholders' ways in which we can make the Governing Documents more adaptable and flexible for alternative methodologies in applying fuel taxes especially with respect to alternative fuels. The goal is to allow our Agreement and platform to have options for membership as the sourcing of revenue for infrastructure continues to evolve.



What to look forward to in 2025

We believe 2025 will be an exciting time for IFTA, Inc., and the stakeholders we serve. Starting with a new format for our 2025 IFTA Educational Forum. After the success of our inaugural 2024 IFTA Educational Forum we listened to your feedback and believe we have made some changes to the format that will make it even better. Select your field of study for breakout tracks that will focus on what you care about the most, but we still maintain that opportunity to commingle with other types of stakeholders during the third breakout each day. We also have an exciting keynote speaker to set the tone for the week and some great relevant topics during our general sessions. 

The budget for the FYE 2025 was approved by membership as well as a dues increase which will go into effect for the 2026 Fiscal Year.





FMCSA/SAFER Data on the Clearinghouse

When searching for Demographic data on the Clearinghouse, you can now click on the USDOT Number to pull up FMCSA/SAFER data from their Mobile API.

We received permission from FMCSA to provide a link to their site which is open to anyone according to H.R.1770 - OPEN Government Data Act

This bill requires open government data assets made available by federal agencies (excluding the Government Accountability Office, the Federal Election Commission, and certain other government entities) to be published as machine-readable data.

Check Your Data

Reminder: Please check your data. When your Detail and Summary Transmittal Data is loaded to the Clearinghouse you will get an email notification that your data has been posted. In that email, if your jurisdiction is listed as newly uploaded, your total comparison between your Detail and Summary Totals data is also displayed. Please check this portion of the email to look for any differences that don't total to 0.00. In addition, on the transmittal front page, top left, there is a link to view these differences as well. It is very important you take a couple of moments to check this data, as it's very important when we do the monthly Funds Netting run.

Program Compliance Review Committee Update

- The PCRC Review Guide is being updated with a clearer presentation of Records Review criteria. It will be posted to the Program Compliance Review Committee page in the near future.
- Calculation for the maximum number of Records Reviews for audit credit:
The annual 3% Audit Requirement X 25% = the maximum annual audit credit from completed records reviews. 3 records reviews = credit for 1 audit.
- The Program Compliance Review Committee currently has a Western Region opening. To volunteer for an IFTA Committee log into the IFTA website then complete and submit the volunteer form available from the website.
- The PCRC is actively working on an IFTA Board Charge with the goal of streamlining the review process, providing jurisdictions with updates on audit count, and looking at transmittal information more frequently.

IFTA Board of Trustees – Appeals Hearing

The IFTA Dispute Resolution Committee (DRC) recently conducted a Hearing prior to the 2024 IFTA Annual Business Meeting. The Program Compliance Review Committee (PCRC) identified that Connecticut, Maryland, and Massachusetts were out of compliance with the audit requirements for two consecutive review cycles and were issued a Final Determination Finding of Non-Compliance (DFNC).

The DRC upheld the PCRC's findings and determined that all three jurisdictions were non-compliant. Final Orders issued by the DRC were sent to the three jurisdictions and can be accessed on the IFTA, Inc. website: <https://www.iftach.org/committee/drc/>

The DRC Hearing followed a process that was ratified by membership and is completely autonomous from the IFTA Board of Trustees and IFTA, Inc. The IFTA, Inc. Board of Trustees, as the appellate body, was not allowed to attend the DRC Hearing and had absolutely no role in the determination of the Final Order of the DRC.

Subsequent to the issuance of the DRC Final Order, the three jurisdictions exercised their right to appeal to the IFTA, Inc. Board of Trustees. The IFTA, Inc. Board of Trustees reviewed the appeals request and unanimously agreed to hear the appeals. The Appeals Hearing will occur on February 3, 2025, in conjunction with the 1Q2025 IFTA, Inc. Board of Trustees meeting. IFTA Commissioners and Assistant Commissioners will be provided with a TEAMS link to access the Appeals Hearing.

- ❖ The Third Quarter Board Minutes, Board Actions via Email and Conference Call were approved.
- ❖ 2025 Board Meetings: **The board will be conducting the DRC Appeals Hearing in conjunction with the 1Q Board Meeting on Monday, February 3, 2025, in Palm Springs, CA.**
 - **1Q 2025:** February 5th and 6th. Palm Springs, CA – Hyatt Palm Springs.
 - **2Q 2025:** April 15th and 16th. Atlanta, GA – Hyatt Centric Buckhead.
 - **3Q 2025:** in conjunction with the ABM. August 18th. Salt Lake City, UT – Hilton Salt Lake City Center.
 - **4Q 2025:** October 28th and 29th. Chandler, AZ – Crowne Plaza.
- ❖ Learning Management System (LMS): DRC Training and New Auditor Training is underway. Discussed short-term and long-term solutions for the new platform. The new platform will be implemented by February 1, 2025.
- ❖ The Board moved to approve the position of the Attorney Advisory Committee (AAC) Vice-Chair to Mr. Andrew Owens (VA) and the two (2) open at large positions to Mr. Nick Ramos (SD) and Ms. Katarzyna Kowalska (IL).
- ❖ The Board moved to approve funding the Board of Trustees and the presenters for the 2025 IFTA Educational Forum.
- ❖ The Board moved to approve the 2026 event locations.
- ❖ IFTA continues to be present at conferences and meetings.
- ❖ The overall organizational financial budget and the investment portfolio remain financially sound.
- ❖ The 2025 IFTA Educational Forum is well underway. Registration is open with Early Bird Pricing which expires on December 31, 2024.

IFTA, Inc. Logins

For enhanced security, we've made some changes to the login process on our site.

1. ****Login Attempt Limits****: If you make 5 failed login attempts within 1 hour, you'll be temporarily locked out. A countdown timer will display the remaining time until you can attempt to log in again. This measure is in place to prevent rapid-fire login attempts and strengthen overall security.
2. ****Improved Login Access****: We've also introduced a new feature to streamline the login process. You can now log in directly from any public page. Simply click the login link, and a modal window will appear where you can enter your credentials. After logging in, the page will refresh automatically, and you'll be signed in without needing to navigate back to your previous page.

Please note, this update is substantial, and we will be thoroughly testing it across all public and secure pages to ensure a smooth experience and prevent any issues. Thank you for your patience as we implement these improvements!

IFTA's Directors At Work

Financial Corner

It was a busy Annual Business Meeting this past August in St. Louis. Please take note that there were items that came up that may affect the budgets of the member jurisdictions.



The big news was that the IFTA membership passed a dues increase. The dues for the 2026 Fiscal Year will be \$27,000. The invoices for the 2026 fiscal year will be sent out on March 31, 2025. The due date will be July 1, 2025. There is a grace period until July 31, 2025 for dues to be paid and to be considered timely. After July 31, any jurisdiction that has not submitted their dues payment may be considered inactive.

Article R1545.200 states that “(t)o retain an active membership status, the jurisdiction must (p)ay membership dues in a timely manner. Voting privileges provided in the Articles of Agreement R1546 are granted to only eligible jurisdictions holding active membership status.”

During the 4th quarter 2024 Board of Trustees meeting, the Board directed IFTA, Inc. to monitor the dues payments and consider denying voting privileges to any inactive jurisdiction per Article R1546. Article R1546 states that “(v)oting privileges are granted to eligible member jurisdictions as defined the IFTA Articles of Agreement section R220.”

Please plan on paying your dues timely. IFTA, Inc. will send out reminders to those jurisdictions that have not paid the dues by July 1 and a second reminder on July 31. If payment is not received, or alternative arrangements have not been made with IFTA, Inc., you may lose your ability to vote at the 2025 Annual IFTA Business Meeting.

Deputy Director's Insight

Greetings everyone and Happy Holidays!

It's hard to believe I'm even saying that! What a year it has been! There is so much going on with your Directors, I hardly know where to start. So, let's stick with some highlights:

- The IFTA Interest Rates effective January 1, 2025, and for the 2025 calendar year have been posted. You may have noticed that our initial posting and advisement to membership on the U.S. Jurisdiction rate was updated just a few days later. This is due to the Internal Revenue Service announcing on November 18, 2024 a change in the underpayment rate for the 1Q2025 period. Since 2013, and as a result of the passage of IFTA Ballot 2-2010, IFTA has determined the effective interest rate based on the IRS bulletin published for the 4th quarter of the current year. We have never seen a change made by the IRS this late in the year nor have we seen a downward trend before. Thus, with the announcement by the federal government, the IRS underpayment rate is being set at 7%, effective January 1, 2025. In accordance with IFTA Articles of Agreement R1230.100, the IFTA Interest Rate for U.S. jurisdictions will be set at **nine percent (9%)** effective January 1, 2025. - On the LMS front, there are two important items to report. The LMS (Learning Management System) is currently in transition. As you may know, IFTA was informed in August 2024 that IRP would cease using the i2Learning Hub at the conclusion of the contract with Totara. The end date for the contract with Totara was November 1, 2024. As an interim measure, IFTA elected to engage in a three-month extension with Totara. Please be advised that all IRP only material has been deleted from the platform as the International Registration Plan no longer has a contract with Totara. If you access the current LMS through your IFTA, Inc. website login, you will notice no difference in accessing the IFTA material and sessions. **BUT**, of greater note, we have some really exciting news for everyone in the IFTA community. The IFTA LMS is migrating away from the Totara platform. One of the features that has made the LMS so popular and user friendly is the use of “single sign on” (SSO) technology. We discovered that with IRP's departure, Totara could not continue to support the same SSO programming without IFTA incurring a significant cost to rebuild it for the sole use of IFTA. Too technical? Yes, but a critical component of why we have pursued a different platform. True to form, our IT personnel (Jason DeGraf and Tom King) have been “all over it”. We will have the same SSO capabilities so that you will not need to do anything other than login to the IFTA website and click on the link to the LMS. The **bigger** news is yet to come. We are in the process of totally rebranding the LMS so that when you think of online education for IFTA, the new and catchy name will immediately come to mind. Migration of user information, courses and sessions, and available certificates will take place throughout the month of January 2025. Look for announcements to promote the new platform and some exciting and new course selections beginning right after January 1, 2025, with implementation set for February 1, 2025.
