Approval of Minutes

The minutes from February APC conference call held on February 10, 2010 were approved by unanimous consent.

Meeting with LEC and Agenda for 2010 IFTA Managers and Law Enforcement Seminar

- Cindy, Andrew, Pam and Debbie had a conference call; they had discussion about replacing the breakouts by only general sessions, all in one room
- ➤ Debbie would like to know if IRP are going to need a room for a breakout presentation or will they be doing it in a general session? Bill and Rob are having a phone call this afternoon, so Bill will ask. Debbie needs to know in advance in order to release the rooms at the hotel.
- It seems that LEC will agree on whatever is proposed by APC; Pamela and Cindy are having a conference call tomorrow with LEC.
- Discussion continues on pros and cons for only general session:
 - Everyone hears the same info if all in one room
 - Less interactions due to the bigger group
 - If the group is small, like last year it's ok, but with a big group, not so sure
 - It also depends if all the topics have an educational purpose
 - With breakouts, people have a chance to leave...
 - A good agenda from both (LEC and APC) will be interesting for everyone
 - To present the topics all in one room assure that everybody will have the chance to listen to every subject, even the presenters who have to repeat their presentation twice and miss the other ones

- General Sessions or breakouts, Cindy will need presenters!
- Tammy mentioned that LEC suggested having an opening reception on Wednesday night
 - This implies that we might have to increase the registration fee.
 - Pam asks if we will save money if we use only one room, Tammy answers that usually the other rooms are free; we will save only on the electronic materials.
 - Cindy mentions that with the economic problem, maybe it is better to keep the registration fee as low as possible
 - According to Tammy, this reception could cost from 20 to 30 \$ per person, Tammy will get back to us with the information.

Other item of Business

Bill is looking for presenters at the Seminar.

Ghyslaine would like to know if the same articles are presented each year in the IFTA 101 'course'. The answer is that it's up to the presenter but usually the most important ones are used. This course is presented to new people so they get an overview of IFTA. It is usually presented at 8h30 before the opening, on the first morning. Debbie reminds us that in the comments, people suggested that it should be presented as a general session.

Bill says that, after the Board Meeting in April, we will know what fees are going to be paid by IFTA Inc for the committee members.
