Revision of Charter ITAC

<u>Funds Netting</u> Amanda from IFTA, Inc. said \$65,000,000.00 was submitted, with 1 Jurisdiction funding late. Texas and Louisiana had error of \$20,000,0000.00 They are working on fixing the problem.

Quality Control Subcommittee

Cherie Woodworth contacted 3 of the 4 Canadian Provinces (BC, MB, QC and ON) on how they figure the exchange rates for transferring money to the Clearinghouse. British Columbia was the only Province to return her call and she found that BC said that monies under \$50,000.00 they went by the Provisional day rate and anything over \$50,000.00 was done at the Federal day rate. This is a violation of the IFTA agreement. There was some discussion about rounding and exchange rates. There is some guidance on this in the procedure manual. they should be given guidance on the correct approach per the Bank of Canada. Cheri and Debbie will write a letter of a plan of action and follow through.

Transmittal ID numbers
