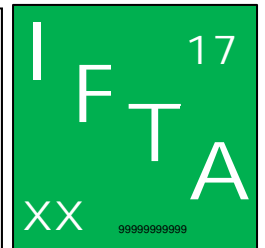

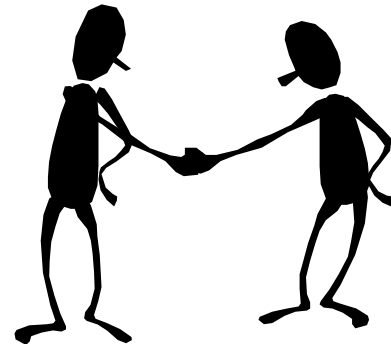

If you fill this section out it will make it easier for IFTA, Inc. to contact the right person who handles your demographics should errors in uploads occur.

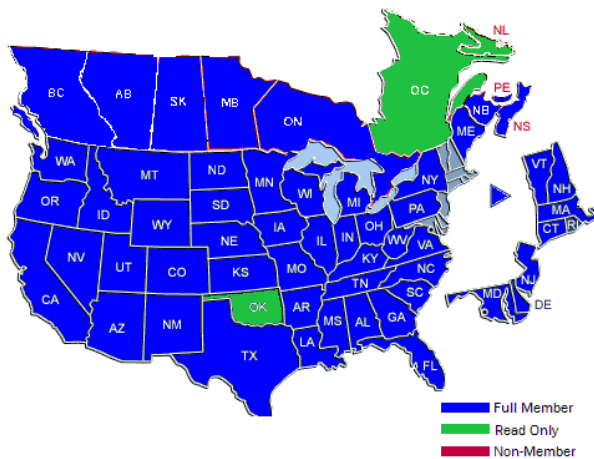
Check Your Links

July 2017 Demographic Full File Upload Deadline

Starting July 1, 2017, all Jurisdictions will be required to provide full baseline updates to the Clearinghouse demographic database. This file will be a complete snapshot of your current demographic database, sent to us nightly. Also at this time, we expect all jurisdictions to have their data cleaned up in regards to any errors the Clearinghouse is currently finding. Emails are being sent to each jurisdiction pointing out data errors. You can also use the demographic web pages to find and view errors.

If you still not have attempted to correct your data, we strongly recommend that you do so.
