
- The purpose of the CAC is to provide technical guidance on the components of the IFTA, Inc. Clearinghouse and ensures that the business rules, including the type, consistency and timelines of submitted data are followed.
- CAC is currently working on Best Practices Guides for demographic and transmittal data. The Guides will provide membership with useful information on all aspects of the IFTA, Inc. Clearinghouse. These Guides, when completed, will be available to membership on the IFTA, Inc. site. Stay tuned for further updates on this exciting initiative.



- Is your jurisdiction ready for July 1, 2017? The CAC would like to remind member jurisdictions that effective July 1, 2017; IFTA Ballot #03-2015 comes into effect.
- This requires a demographic data upload for each business day. CAC recommends jurisdictions, if they haven't already, to implement this change as soon as possible in order to avoid any delays and ensure there is sufficient time to work out any data transmission issues etc.
- CAC is currently working with IFTA, Inc. and jurisdictions to ensure a smooth transition. If you or your
 jurisdiction have any questions or require assistance with this upcoming change, feel free to contact any


