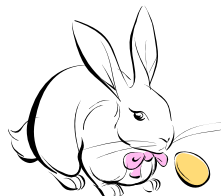

FIRST THINGS FIRST!

The IFTA Clearinghouse is new to some but very familiar to others. Check out two Frequently Asked Questions (FAQs) below about the Clearinghouse from newcomers.

Q: How do I sign up for the Clearinghouse?

A: A person with an IFTA, Inc. login security level five or six clearance must access the website via www.iftach.org on the *Clearinghouse User Registration* link. This is where users can be added.




Found these FAQs helpful? These and more will be included in the Best Practices Guides that the CAC is currently working on. Stay tuned for further updates on this exciting initiative.

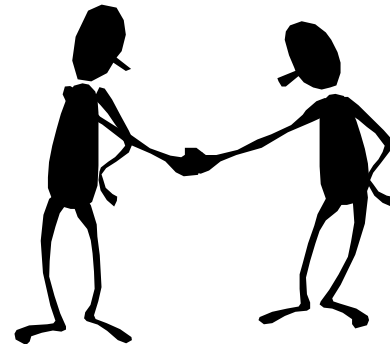


- Is your jurisdiction ready for July 1, 2017? The CAC would like to remind member jurisdictions that effective July 1, 2017; IFTA Ballot #03-2015 goes into effect. This ballot can be viewed at www.iftach.org under *Ballot Proposal* tab.
- This requires a demographic data upload for each business day. CAC recommends jurisdictions, if they haven't already, to implement this change as soon as possible in order to avoid any delays and ensure there is sufficient time to work out any data transmission issues etc.
- CAC is currently working with IFTA, Inc. and jurisdictions to ensure a smooth transition. If you or your jurisdiction have any questions or require assistance with this upcoming change, feel free to contact any member of the CAC (our contact information is located on the CAC page of the IFTA, Inc. site).

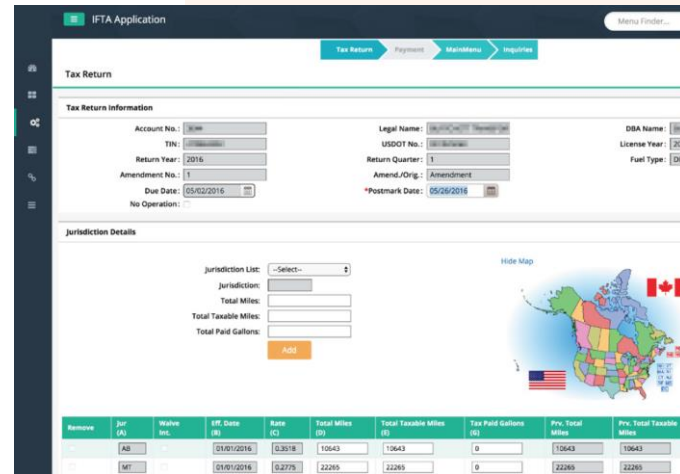

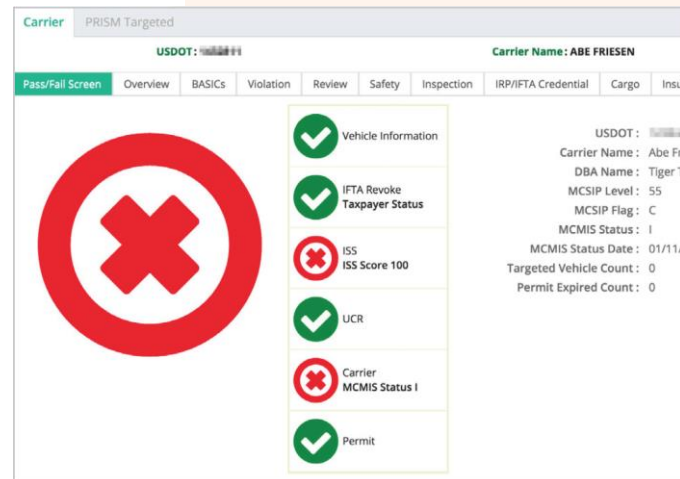

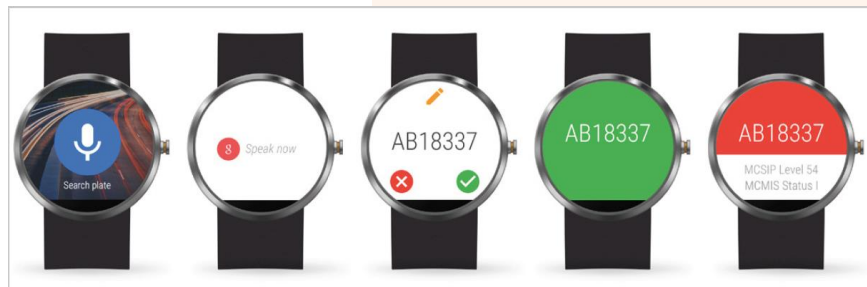
