Have you ever looked at the **Status Breakdown** section on the IFTA Demographics site? It can be found on the Clearinghouse home page.

Do the active accounts for your jurisdiction resemble the total reported on your annual report?

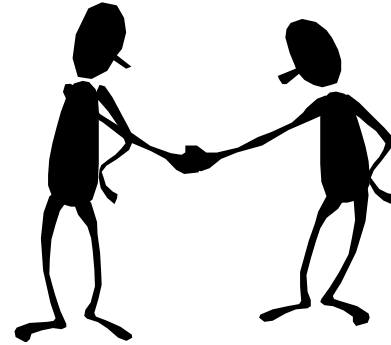
