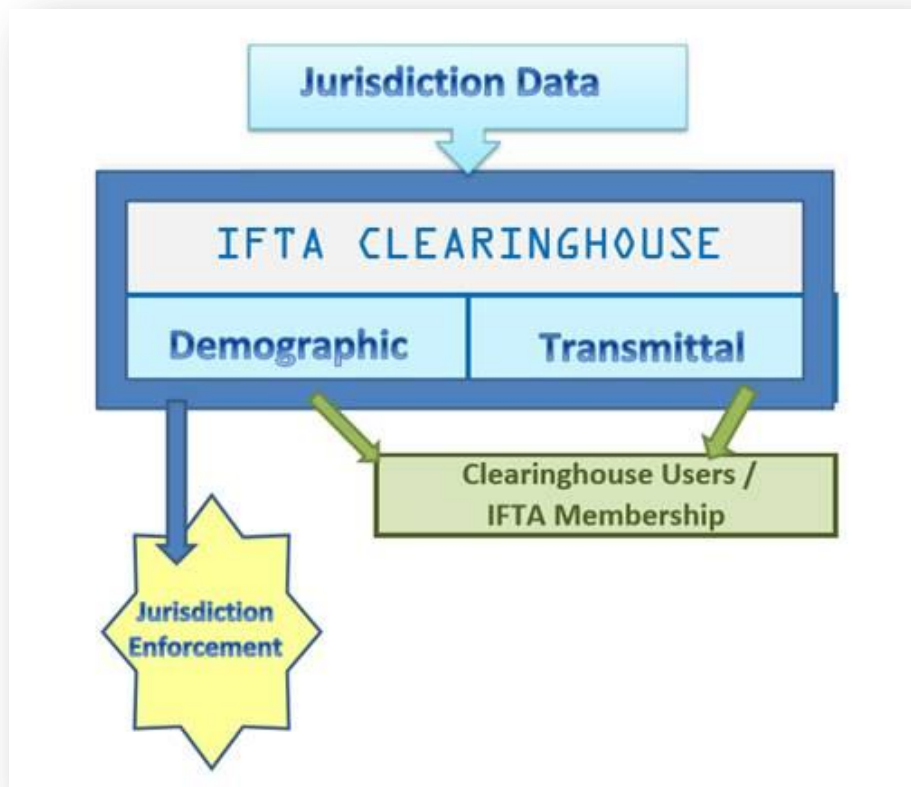

Are you familiar with the IFTA Clearinghouse? Do you know the purpose of the IFTA Clearinghouse?



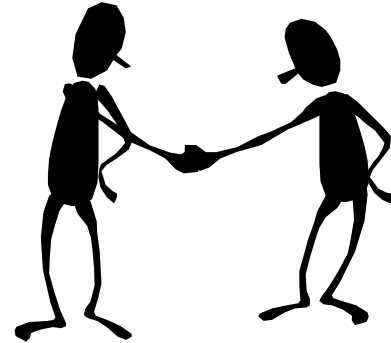
The International Fuel Tax Agreement (IFTA) provides for the distribution of motor fuel use tax revenue among the participating jurisdictions through Funds Netting. There are currently 58 jurisdictions participating in the Clearinghouse including 56 full participants and two read-only participants. The Demographic data contained in the Clearinghouse allows jurisdictions the ability to screen new applicants and quickly verify a carrier's information. The data also allows for enhanced roadside enforcement, allowing enforcement staff across all the jurisdictions to verify carrier information including licensee number, name, and current status.
