


# CTS-CVIEWnow™ Wearable App

CTS-CVIEWnow is the first smartwatch app using voice entry of a license plate number to quickly return a motor carrier's safety snapshot. Results are based on configurable criteria (MCSIP, MCMIS, ISS, etc.), giving an at-a-glance indication of pass/fail. After an inquiry is performed the data can also be passed to a mobile device or computer for further review.
